

COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of County Commissioners met April 9, 1940 at 9:00 o'clock A. M., all members present, Fred F. Hansen presiding.

It was decided by The Board that the Community Room in the Court House could be used for meetings by any group or organization on compliance with certain restrictions. Any group using this room for meetings will be held responsible for any damages, and are asked to turn off the lights when through and adjourn the meeting by midnight. Dates for meetings can be arranged with Custodian, A. E. Robertson or County Clerk, R. G. Engstrom.

Thereupon The Board adjourned until April 10, 1940, to meet at 3:00 o'clock P. M.

The Board met April 10, 1940 at 3:00 o'clock P. M., with all members present, Fred F. Hansen, Chairman.

George and Frank Spiegelberg of the Spiegelberg Lumber and Building Company, together with Architect, F. H. Porter, met with The Board, relative to advertising the final payment and completion of P. W. A. Project No. Wyo. 1083 F.

It was decided after conferring with Mr. E. F. Sullivan and County Attorney, J. J. Hickey, that bond, satisfactory to The Board, should be furnished by the Contractor, guaranteeing completion of the various small jobs as enumerated by Architect, Mr. Porter and the Board, before this advertising starts.

On motion made by Commissioner McCarthy and seconded by Commissioner Gooldy the following Resolution was adopted, authorizing County Clerk to proceed with advertising of Notice of Completion and Final Payment as follows:

Under the provisions of Sections 95-301, of Wyoming Revised Statutes, 1931, as amended by Chapter 78, Session Laws of Wyoming, 1935, notice is hereby given:

(1) That the County of Carbon, through its Board of County Commissioners at the Court House at Rawlins, Wyoming, has accepted Contract No. 2 of the Spiegelberg Lumber & Building Company, for the construction of Court House and Jail Building, Rawlins, Wyoming, known as Wyoming Project P. W. A. No. 1083F, as completed in accordance with specifications and as set forth in the contract by the County of Carbon, Rawlins, Wyoming, dated April 7, 1939, and that the contractor is entitled to final settlement therefor.

(2) That upon the 2 day of June, 1940, the County of Carbon at Rawlins, Wyoming, will pay the contractor the full amount due him under said contract:

(3) That nothing in the above mentioned Section 95-301 of the Wyoming Revised Statutes, 1931, as amended, shall be construed as relieving the Contractor and the Sureties, on his bond, from any claim for work or labor done or materials or supplies furnished in the execution of the Contract.
