Shockley and George Blair, being presented to the Board of County Commissioners, and after due consideration of the respective protests, The Commissioners considered the matters at length. A motion was made by Commissioner Hansen, seconded by Commissioner McCarthy and unanimously carried, that the appraisal made by George C. Austin, Charles Vivion and Gus Larson be accepted in each of the above cases. The Board further concluded that they would recommend the installation and erection of all necessary under-passes, over-passes, cattle guards and culverts on the proposed Baggs-Dixon road as the same are requested by the land owners adjacent to the right-of-way.

There being no further business to come before the Board, the meeting was duly adjourned subject to the call of the Chairman.
