SPECIAL MEETING.

THE BOARD OF COMMISSIONERS MET FEB. 3, 1941 AT 10:00 O'CLOCK A. M. ALL PRESENT, JOHN F. GOOLDY PRESIDING. IN COMPLIANCE WITH SECTION 6, CHAPTER 87, WYOMING SESSION LAWS 1939, A PUBLIC HEARING WAS HELD RELATIVE TO THE CARBON COUNTY BUDGET AS PROPOSED FOR 1941.

SEVERAL CHANGES WERE MADE IN THE BUDGET AS AUTHORIZED BY THE 26TH LEGISLATURE OF THE STATE OF WYOMING, AMENDING THE 1939 COUNTY BUDGET LAW.

ON MOTION BY COMMISSIONER HANSEN, SECOND BY McCARTHY AND SO CARRIED, THE REQUEST OF THE CARBON COUNTY LIBRARY BOARD FOR A BUDGET OF \$7000.00 WAS APPROVED.

A MOTION WAS MADE BY COMMISSIONER McCARTHY, SECONDED BY HANSEN AND UNANIMOUSLY CARRIED, THAT THE REQUEST OF THE CARBON COUNTY MEMORIAL HOSPITAL BOARD FOR A ONE-HALF ($\frac{1}{2}$) MILL LEVY WHICH WILL RAISE APPROXIMATELY \$12500.00 BE APPROVED.


