Mr. R. D. Barber of the American Telephone and Telegraph Company of Wyoming, met with the Board to discuss crossing of County roads and highways with its communication system. ROAD

A motion was made by Hansen and seconded by McCarthy and unanimously carried, that resolution be adopted granting the American Telephone and Telephone Company of Wyoming, authority to construct, operate, maintain, replace and remove underground communication systems within, along and across the county roads and highways in the County of Carbon, State of Wyoming.

RESOLUTION.

WHEREAS, AMERICAN TELEPHONE AND TELEGRAPH COMPANY OF WYOMING desires to construct, operate, maintain, replace and remove under-ground communication systems within, along and across the county roads and highways in the County of Carbon, State of Wyoming:

BE IT RESOLVED by the Board of the County Commissioners of the County of Carbon, State of Wyoming:

That consent, permission and authority be and they are hereby granted to the American Telephone and Telegraph Company of Wyoming, its ^{associated and allied companies} and their respective successors, assigns, lessees and agents, to construct, operate, maintain, replace and remove such communication systems as the grantees may from time to time require, consisting of underground cables, wires, conduits, pipes, manholes, drains and splicing boxes, and surface testing-terminals and markers and other appurtenances within, along and across the county roads and highways in the County of Carbon and State of Wyoming:

All such communication systems shall be installed under the direction and supervision of the County Engineer and all roads and highways that may be disturbed or damaged in the construction, maintenance, replacement or removal of said systems shall be promptly replaced and repaired by the grantees at their own expense and to the satisfaction of the County Engineer.
