The Board of County Commissioners met May 26, 1942, at 10:00 o'clock A. M., all members present, John F. Gooldy, chairman.



MINUTES OF COUNTY BOARD OF
EQUALIZATION

The Board of County Commissioners of Carbon County, Wyoming met May 25th, 1941 at 10:00 A. M. as provided by Ch. 115, Art. 22, W.R.S., 1931 as a County Board of Equalization. Mr. Gooldy and Mr. Hansen were present and Mr. McCarthy was absent. R. A. Hakala, Deputy County Assessor, was appointed clerk of the meeting. The Board began a routine investigation of the assessment roll for 1942.

May 26th, 1942. Meeting called to order with all members present. The Union Pacific Coal Co. appeared through its agents, I. N. Bayless, J. A. Brown, A. R. McMicken, H. Jones, George Pryde and O. G. Sharrer to protest the assessed valuation of the U. P. property in Hanna as made by the Assessor. After some discussion, a subcommittee composed of Mr. Pryde, Mr. Bayless and Mr. McMicken for the Union Pacific and Wm. A. Johnson, J. J. Hickey and R. A. Hakala for the County retired to effect a compromise that would be satisfactory to both parties. The solution offered the Board was a flat 50% increase in the valuation of the Power Plant and a \$20,000.00 increase on the balance of the equipment. The Board accepted these figures.

May 27th, 1942. Meeting called to order with all members present. Mrs. Mayme Niland appeared and asked the Board to recheck the valuation of her recently acquired property on Maple St., Rawlins. The Board instructed the Assessor to do this and he reported that the original appraisal figure was fair and that no increase should have been made for improvements since the appraisal was made and any improvements were in the nature of upkeep. The Board finished their check of the assessment roll and adjourned until the second meeting which was required by statute to be on June 8th, 1942.
