

COMMISSIONERS' PROCEEDINGS

Regular Meeting

The Board of Commissioners met September 1, 1942, at 10:00 o'clock A. M., all members present, John F. Gooldy, Chairman.

The minutes of meetings held August 3rd and 4th were read and approved.

A committee composed of the following men met with the Board of Commissioners relative to the proposed abandonment of the Saratoga & Encampment Railroad by the Union Pacific R. R. Company: F. H. Healey, W. M. Englehart, J. F. O'Sullivan and J. D. Rice, the latter two of Kansas City, Missouri. After due consideration a motion was made by Commissioner McCarthy, seconded by Hansen and unanimously carried, whereby the following Resolution was adopted and placed on file in the office of the County Clerk together with Exhibits "A" and "B".

RESOLUTION OF BOARD OF COUNTY COMMISSIONERS
OF CARBON COUNTY, WYOMING, OPPOSING THE
ABANDONMENT OF THE SARATOGA & ENCAMPMENT VALLEY
RAILROAD, DATED SEPTEMBER 1, 1942.

WHEREAS, The citizens and residents of the Saratoga and Encampment Valley and Carbon County, Wyoming, purchased the property now known as the Saratoga and Encampment Valley Railroad running between Walcott and Encampment in said county, for \$101,605.90, and delivered the title thereto, free and clear of all encumbrance to the Union Pacific Railroad Company and to its nominee, Saratoga and Encampment Valley Railroad Company, under an agreement between a "Citizens Committee" and Union Pacific Railroad Company, dated June 20, 1928, providing for the conveyance and permanent and perpetual operation of the Saratoga and Encampment Valley Railroad by Union Pacific Railroad Company or its wholly owned subsidiary aforesaid, copy of which agreement is hereto attached, marked Exhibit "A" and made a part hereof by reference, and

WHEREAS, On July 3, 1942, Union Pacific Railroad Company published or caused to be published in the public press in Carbon County, Wyoming, a certain letter addressed to said "Citizens Committee" apprising said "Citizens Committee" that it proposed to apply for a certificate of abandonment of said Saratoga and Encampment Valley Railroad and proposed in connection with said abandonment to refund the \$101,605.90 to those who had subscribed to said fund in 1928, and

WHEREAS, Said "Citizens Committee" following a general meeting of the citizenry of the Saratoga and Encampment Valley and the subscribers to said fund, advised Union Pacific Railroad Company that they intended to and would protest and vigorously contest any attempted abandonment of said Saratoga and Encampment Valley Railroad and any branch, by Union Pacific Railroad Company, of its agreement to permanently and perpetually operate said Saratoga and Encampment Valley Railroad, and

WHEREAS, Union Pacific Railroad Company thereafter on July 30, 1942 published or caused to be published in the public press a second letter to the "Citizens Committee" wherein said committee and the subscribers to said fund are threatened with both the loss of the facilities of said Saratoga and Encampment Valley Railroad and the amounts of their respective subscriptions to said fund and

WHEREAS, Saratoga and Encampment Valley Railroad Company and Union Pacific Railroad Company did on August 1, 1942 file with the Interstate Commerce Commission at Washington, D. C., an application for certificate of public convenience and necessity permitting the abandonment of the railroad extending from Walcott to Encampment, a distance of approximately 44.02 miles all in Carbon County, Wyoming, which proceeding bears Finance Docket No. 13864, and

WHEREAS, SAID Saratoga and Encampment Valley Railroad exclusively serves an area covering 1,500,000 acres as shown on the accompanying map, marked exhibit "B" and made a part thereof by reference, of which 100,000 acres are irrigated lands; a community having a population of 3,000 people; wherein 21,000 cattle, 3,000 horses, 28,000 head of sheep, approximately 100,000 acres of hay, grains, potatoes and vegetables are being raised annually, said area contains in excess of 1,000,000,000 feet of merchantable timber; from which 2182 carloads of non-revenue freight consisting of props, wedges, lumber and ties used by the Union Pacific Railroad over its own system have originated since January, 1937; and

WHEREAS, in Interstate Commerce Commission's Finance Docket No. 13,366 entitled, "Laramie, North Park and Western Railway Abandonment" (which abandonment was denied July 11, 1942) the Union Pacific's Engineers testified that the continued operation of that railroad was unnecessary because Union Pacific's props, poles, wedges, lumber and ties were now being produced and procured from the territory served by the Saratoga and Encampment Valley Railroad, and

WHEREAS, said railroad sought to be abandoned also serves a large and vital mining district the full and complete operation whereof is imperative in the National Defense from which district copper, vermiculite, iron, lead, zinc, graphite, fluorspar and other minerals in substantial quantities are being produced and in many instances production of strategic minerals are about to be produced on a large scale, none of which can be marketed should said railroad be abandoned, and

WHEREAS, the world's largest quantity and toughest quality of vermiculite comes from the area served by said railroad sought to be abandoned, that same has been commercially produced therefrom for the past six years; that both the United States Army and Navy are specifying its use in roofing, insulating and fireproofing strategic defense areas to prevent fire losses from incendiary bombings and other causes; that the Army and Navy demand for this material far exceeds any known supply; that none of the large body of this strategic material in the Encampment Valley can be supplied without the transportation facilities of the Saratoga and Encampment Valley railroad and that arrangements are now being concluded to mine and process very large quantities of this vermiculite, and

WHEREAS, the serious rubber shortage and the stringent tire and truck rationing programs in effect make it both impracticable and impossible to truck livestock, hay and strategic minerals long distances to rail facilities, and

WHEREAS, the National Defense demands that no railroad should be abandoned during the war emergency which serves developed and even undeveloped mineral resources nor which will impair the efficiency of any important agricultural and livestock raising area dependent thereon.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming, having charge of said County's administrative affairs, that:

1. WE for ourselves and the entire citizenry of said county do decry the filing of said application to abandon the Saratoga and Encampment Valley Railroad and vigorously protest its proposed abandonment.

2. We respectfully request and demand of Union Pacific Railroad Company and Saratoga and Encampment Valley Railroad Company that their joint application before the Interstate Commerce Commission for the abandonment of the railroad facilities between Walcott and Encampment in our county be immediately withdrawn, and that each of said companies take such steps as may be necessary to prevent any attempted requisitioning or sequestration of said rail facilities by any governmental agency.

3. We respectfully request the President of the United States, and request and demand of the War Production Board, Office of Defense Transportation, The War and Navy Departments, and the Maritime Commission that no order requisitioning or sequestering said rail facilities be made or attempt to be made, without there first being granted a full and complete public hearing before some responsible governmental agency as to the alleged necessity of such an order and that such hearing be had at a convenient place in Carbon County, Wyoming.

4. We respectfully request Honorable Joseph C. O'Mahoney, Honorable H. H. Schwartz, United States Senators and Honorable J. J. McIntyre, Congressman, Honorable Nels H. Smith, Governor of Wyoming, Honorable Ewing T. Kerr, Attorney General of Wyoming, Honorable Will M. Lynn, Honorable M. H. Leitner, and Honorable Archie Ewoldsen, constituting the Public Service Commission of the State of Wyoming, to intervene and intercede with all the aforesaid Federal Agencies to prevent said Saratoga and Encampment Valley railroad from being abandoned.

5. A duly executed and attested copy of this resolution be immediately transmitted to the Honorable Franklin D. Roosevelt, President of the United States; Honorable Henry L. Stimson, Secretary of War; Honorable Frank Knox, Secretary of the Navy; Honorable Donald E. Nelson, Chairman War Production Board; Honorable Joseph B. Eastman, Office Defense Transportation; Admiral Emory S. Land, Chairman Maritime Commission and to W. M. Jeffers, President Union Pacific Railroad Company and Saratoga & Encampment Valley Railroad Company, to the end that the lives, property and investments of those served by the Saratoga and Encampment Valley Railroad be protected.

IN TESTIMONY WHEREOF, each of said County Commissioners has hereunto set his hand, thereby evidencing his concurrence in this resolution, September 1, 1942.

- (3) Authorizing and directing the Judges and Clerks of said General Election at said time and place to conduct said election among the qualified electors of Town of Parco in accordance with said Proclamation of Election, and otherwise in conformity with the general laws of the State of Wyoming relating to elections, canvassing of ballots and certifying the results.
