

COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met February 2, 1942, at 10:00 o'clock A. M., all present, John F. Gooldy, presiding.

In compliance with Section 6, Chapter 87, Wyoming Session Laws, 1939, a public hearing was held relative to the Carbon County Budget as proposed for 1942.

A motion was made by Commissioner McCarthy, seconded by Hansen and unanimously carried, whereby the following resolution was adopted:

APPROPRIATION RESOLUTION

WHEREAS, on the 15 day of December, 1941, R. G. Engstrom, the budget making authority, prepared and submitted to the Board a county budget for the year 1942; and

WHEREAS, such budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Carbon County News, a legal newspaper published and of general circulation in the county, for three successive weeks prior to the 2nd day of February, 1942; and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in said proposed budget, all of which more fully appears in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the year 1942.

BE IT FURTHER RESOLVED that the following appropriations be made for the year 1942 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.

A motion was made by Commissioner McCarthy, seconded by Hansen, and so carried, whereby the sum cash on hand and of \$56962.00 was set aside and deducted from the estimated revenues for the year 1942, to be used only, as a working capital fund, in compliance with Sec. 7, Chapter 7, Session Laws of Wyoming, 1941.

The report of the Board of Appraisers, appointed on the proposed Saratoga-Centennial and Saratoga-Encampment Highway was presented to the Board by Isadore Bolten, John Quealy and Frank Cooper, appraisers.

On motion by Commissioner McCarthy, seconded by Hansen, and unanimously carried, the following resolution was adopted:

WHEREAS,

The Board of Commissioners hereby resolve that the proposed Saratoga-Encampment and Saratoga-Centennial Road shall be established in accordance with the map on file in the office of the County Clerk, and, that the appraisal made by Isadore Bolten, John Quealy and Frank Cooper, on the proposed road be accepted, and that the County of Carbon guarantee the right of way to the State of Wyoming and save them harmless from any right of way damages. The report of the Board of Appraisers to be placed on file in the office of the County Clerk, and that each land owner incorporated in the Appraisers' report be notified by registered mail of this action. The Board of Commissioners will hear objections to the Appraisers' report on March 4, 1942, at the office of the Board of Commissioners in the Courthouse in Rawlins, Wyoming.

Thereupon the Board adjourned until February 3, 1942.
