Protests and objections to the report of the Board of Appraisers on the proposed Saratoga-Encampment and Saratoga-Centennial road were heard by the County Commissioners.

After considering the protests and claims for damages, the Commissioners decided to meet with the Wyoming Highway Department officials to discuss same, on March 7, 1942.

Thereupon the Board adjourned until March 5, 1942.

The Board resumed its session March 5, 1942, all members present.

In compliance with Sec. 109-408 and 409 of the W. R. S. 1931, a motion was made by Commissioner McCarthy, seconded by Hansen and unanimously carried, dividing the U. S. Forest Reserve fees amounting to \$7695.66 as follows:

5% to School Districts \$384.78

95% to General Fund \$7310.88

Thereupon the Board adjourned to meet with the Taylor Grazing Board.

The Board re-convened and disposed of several matters of routine County business.

A motion was made and unanimously carried whereby the meeting was adjourned subject to the call of the Chairman.
