The Board of Commissioners met with A. R. McMicken and A. D. Sager, members of the Hospital Board, Mrs. Gladys Hambrick, Superintendent of the Hospital, and Dr. C. W. Jeffrey, to discuss the complaint registered with the Board by Mr. L. E. Armstrong and Mr. Snodgrass. The members of the Hospital Board and Mrs. Hambrick advised the Commissioners that it would be necessary for Mrs. Snodgrass to have special day and night nurses before she could be admitted, due to her condition. The Commissioners were also advised that if the patient was admitted without special nurses, some of the regular nurses and also the Superintendent would resign. It was decided to leave this matter in the hands of the Hospital Board.
