This protest was considered by the Board and a motion was made by Gooldy, seconded by Cheesbrough and carried, whereby this application was rejected.

COUNTY WELFARE DOCTOR. An application was received from Dr. R. B. Baker for the position of County Welfare Doctor. A motion was made by Gooldy, seconded by Cheesbrough and carried that Dr. R. B. Baker be appointed to this position for a two year term effective at once.

An application for membership to the Board of Trustees of the Carbon County Memorial Hospital Board was received from Day. P. Espy. No action was taken as the resignation of J.J. Hickey has not been received.

OFFICIAL COUNTY NEWSPAPER.

The applications of the Republican-Bulletin and Carbon County News for designation as official County newspaper were received. A motion was made by Cheesbrough to designate the Republican-Bulletin as the official newspaper. No second to this motion. A motion was made by Gooldy and seconded by McCarthy, designating the Carbon County News as the official County newspaper. Roll call vote as follows: Cheesbrough-nay, Gooldy and McCarthy-aye.


