

## COMMISSIONERS' PROCEEDINGS

## SPECIAL MEETING

The Board of Commissioners met February 1st, 1943, at 10:00 o'clock A. M. All present, Eugene McCarthy presiding.

In compliance with Section 6, Chapter 87, Wyoming Session Laws, 1939, a public hearing was held relative to the Carbon County Budget as proposed for the year 1943.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried, whereby the following resolution was adopted.

APPROPRIATION RESOLUTION

WHEREAS, on the 4th day of December 1942, R. G. Engstrom the budget making authority, prepared and submitted to the Board a county budget for the year 1943; and

WHEREAS, such a budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Carbon County News, a legal newspaper published and of general circulation in the county, for three successive weeks prior to the 1st day of February, 1943; and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in said proposed budget, all of which more fully appears in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the year 1943.

BE IT FURTHER RESOLVED that the following appropriations be made for the year 1943 and that the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.
