

## COMMISSIONERS' PROCEEDINGS

## REGULAR MEETING

The Board of Commissioners met May 4, 1943, at 10:00 A. M., all present, Eugene McCarthy, Chairman.

The minutes of meetings held April 6, 7 & 8, 1943, were read and approved.

MALT BEVERAGE LICENSE: There being no protest entered a motion was made by Commissioner Gooldy, carried seconded by Cheesbrough and unanimously/whereby malt beverage permit No. 95 was issued to A. R. Anderson of Coyote Canyon, Walcott, Wyoming, for the sum of \$100.00.

RETAIL LIQUOR LICENSE: There being no protest entered a motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried whereby liquor license No. 20 was issued to Orville A. Lart of Lamont, Wyoming, for the sum of \$300.00.

DANCE HALL LICENSE: An application for a Dance Hall License was received by the Board from Gideon Swanson and Ray Bloom, together with check of \$50.00, in compliance with Sec. 65-301, 1931 Statutes. Said dance hall is located  $3\frac{1}{2}$  miles east of Rawlins on Highway 30, on SE $\frac{1}{4}$ NW $\frac{1}{4}$  of Sec. 24, Twp. 21, N. R. 87, West of the 6th P. M., on north side of highway. A motion was made by Cheesbrough, seconded by Gooldy and unanimously carried whereby license No. 2619, was issued for a period of one year.
