

COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met August 7, 1944, at 10:00 o'clock A. M., all members present, together with Deputy County Assessor, Marie Spataro, for the purpose of fixing the Tax Levies for and within Carbon County for the year 1944 in compliance with Sec. 115-135 W. R. S. 1931.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1944 had been found to be \$32,062,624.00; the Deputy County Assessor advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1944 as follows:
