COMMISSIONERS' PROCEEDINGS

REGULAR MEETING

The Board of Commissioners met October 3, 1944 at 10:00 A. M., all present, Eugene McCarthy, Chairman.

The minutes of meetings held September 5 and 6, 1944 were read and approved.

Recommendations were received from the Democratic and Republican Central Committees, suggesting that the Election Boards appointed for the Primary Election held July 18, 1944, be re-appointed for the General Election to be held November 7, 1944, and that the County Clerk be authorized to fill any vacancies that may occur. A motion was duly made, seconded and carried whereby the same Election Board officials were re-appointed for the General Election, November 7, 1944.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried whereby the following Election Proclamation was ordered in compliance with Chapter 36-112, W. R. S. 1931.

ELECTION PROCLAMATION

Notice is hereby given that in compliance with Sections 36-112, 113, 114 and 301, W. R. S., 1931, a General Election will be held in the several voting precincts of the County of Carbon, State of Wyoming, on Tuesday, November 7, 1944, at which the following officers will be chosen, to-wit:

- One President of the United States.
- One Vice-President of the United States.
- Three Presidential Electors.
- One Representative in the Congress of the United States.
- One Justice of the Supreme Court.
- One Judge of the Second Judicial District.

Three members of the House of Representatives of the Twenty-eighth State Legislature.

Proposed Constitutional Amendment Number Two.

One County Commissioner for a term of four years.

One Mayor for the City of Rawlins.

One Councilman for Ward One, City of Rawlins.

One Councilman for Ward One, unexpired term, City of Rawlins.

One Councilman for Ward Two, City of Rawlins.

One Councilman for Three, City of Rawlins.

One Councilman for Ward Three, unexpired term, City of Rawlins.
