The bond of Nels L. Dahlquist, Treasurer of Carbon County Predatory Animal Committee, in the amount of \$5000.00, was approved.

A motion was made by Gooldy, seconded by Cheesbrough, whereby Lance Robinson was appointed as Water Commissioner for District No. 9, Division No. 1, effective May 1, 1944, subject to the approval of The Albany County Board of Commissioners and A. H. Hemingway, Superintendent of Water Division No. 1.

DEPUTY COUNTY ATTORNEY The appointment of Harold M. Johnson as Deputy County and Prosecuting Attorney by S. K. Briggs, County Attorney, was approved by the Board, pursuant to Section 2, Chapter 25, Session Laws of 1935, to serve as Deputy County Attorney during the absence of the County Attorney and to be paid only for such services rendered during the absence of said attorney.
