MEMORIAL HOSPITAL:

The following resolution was received from the Memorial Hospital Board to-wit:

"BE IT RESOLVED, that the emergency or reserve fund in the sum of \$10,000.00, set aside in the Budget of the Memorial Hospital of Carbon County, Wyoming, under the 1945 Budget Act, be held by the County Treasurer and set up as such Emergency Reserve Fund in a separate account on the Treasurer's books, pending any withdrawal therefrom under Statutory proceedings".

A motion was made by Commissioner Gooldy, seconded by Cheesbrough, and unanimously carried whereby this resolution was approved and the County Treasurer authorized to handle this reserve fund for the Memorial Hospital.
