Jan. 4-45 The Board resumed its session, all members present.

The motion was made, seconded and carried, whereby the County Assessor was authorized to proceed with the collection of Poll Tax for the year 1945.

Several matters of routine County business were disposed of.

Budget Officer, R. G. Engstrom, suggested to the Board that the \$17,000.00 in the Emergency Fund for 1944 be transferred to the Working Capital Reserve. A motion was made by Cheesbrough, seconded by Gooldy and unanimously carried, whereby \$17,000.00 was transferred to the Working Capital Reserve

in compliance with Chapter 7 of Session Laws of Wyoming, 1941. The meeting was then adjourned.
