FOREST RESERVE FEES: By unanimous action of the Board, the Forst Reserve Fees in the amount of \$11,159.83 were apportioned as follows:

#### APPRAISERS - BRUSH CREEK-SARATOGA ROAD:

The following appraisers were appointed in compliance with Sec. 52-219, W. R. S. 1931 to view and appraise the above mentioned road as proposed and make a report of their findings to the Board of County Commissioners as soon as practicable. It was also decided that the appraisers should meet at 11:00 A. M. on February 14, 1945, at the Sisson Hotel in Saratoga, Wyoming with the various owners of the lands involved and that the land owners along the proposed road relocation be notified by the County Clerk. The Board suggested that the appraisers make an immediate report to the County Clerk so that same could be submitted to the State Highway Department before the next meeting of the Highway Commission, which will be held the latter part of February. J. F. Mahoney, Rawlins; A. E. Robertson, Rawlins; and R. E. Cooper, Medicine Bow, were appointed as appraisers.

There being no further business the meeting was adjourned.
