TRANSFER OF FUNDS FROM CASH RESERVE:

On May 7, 1946 the Board of Commissioners authorized the Budget Officer to publish notice of intention to transfer \$1000 to the Sheriff's budget and \$1000 to the Courthouse & Jail budget in compliance with Sec. 11 Chapter 110 of the Municipal Budget Act, Session Laws 1945.

There being no protests or objections presented, a motion was made by Commissioner Gooldy, seconded by Cheesbrough and carried whereby the following resolution was adopted:

R E S O L U T I O N

WHEREAS, the budget appropriation for the County Sheriff's office for 1945-1946 has become depleted by reason of unexpected criminal costs requiring an abnormal amount of traveling in making arrests; and

WHEREAS, the budget appropriation for the Courthouse & Jail has become depleted by reason of unexpected costs for the Board and care of prisoners;

NOW, THEREFORE, be it resolved that the County Treasurer be and is hereby authorized to transfer the sum of \$1000 each to the Sheriff's budget and the Courthouse & Jail budget from the Cash Reserve Fund to supplement these budgets.

ROAD & BRIDGE SINKING FUND:

A motion was made, seconded and unanimously carried whereby the County Treasurer was authorized to set aside as a separate ledger entry the sum of \$10000 from the General Fund to the Road & Bridge Sinking Fund as provided for in the 1945-1946 budget appropriation which was included in the General Fund and adopted in the appropriation resolution on July 23, 1945.

CENTIENNIAL-SARATOGA and RAWLINS-MEDICINE BOW ROADS: A motion was made, seconded and unanimously carried and the following resolution was adopted: RESOLUTION

The Board instructed the County Clerk to notify the Wyoming Highway Department that all legal requirements have been complied with in the matter of the location of the above roads, and that the time for protests or claims for damages has expired as of Mar. 11, 1946 and May 8, 1946 respectively, no further action being necessary. NOW, THEREFORE, be it resolved that the right of way has been established.

UNIVERSITY SCHOLARSHIP:

On the recommendation of Irwin S. Barnett, Superintendent of the Platte Valley High School in Saratoga, and in compliance with Chapter 74 of the Session Laws of Wyoming, 1941, the Board unanimously awarded a Wyoming University Scholarship to Miss Helen Marie Doherty of Saratoga.

TRANSFER OF FUNDS:

The Board authorized the Budget Officer to publish notice of intention to transfer \$16750 to the following budgets from the Cash Reserve fund in compliance with Sec. 11, Chapter 110 of the Municipal Budget Act as adopted in the Session Laws of Wyoming, 1945, the said hearing to be held at the office of the Board of Commissioners at Rawlins, Wyoming on June 15, 1946 at 10:00 A. M. at which time any and all persons interested may appear and be heard respecting such transfer of funds.
