## THE MEMORIAL HOSPITAL OF CARBON COUNTY

A motion was made by Commissioner Cheesbrough, seconded by McCarthy and carried whereby the following resolution was adopted:

RESOLUTION

WHEREAS, the management of The Memorial Hospital of Carbon County, a body corporate, under the present Board of Trustees of said institution has been unjustifiably lax in the performance of their duties as said Board; and

WHEREAS, the Board of Trustees of The Memorial Hospital of Carbon County have failed and neglected to account for the actions of their employee, the Superintendent of said hospital Gladys N. Hambrick, for the period from September, 1940 to December 8, 1945 in the depositing of monies collected from patients of said institution; and

WHEREAS, the Board of Trustees of The Memorial Hospital of Carbon County; W. W. Daley, A. R. McMicken, Joseph H. Neath, Day P. Espy, and E. P. Murphy, have neglected and failed, as a Board of Trustees, to perform those acts enjoined upon them by law in the operation of The Memorial Hospital of Carbon County to the satisfaction of The Board of the County Commissioners of the County of Carbon; and

WHEREAS, it being to the best interests of the people of the County of Carbon that the Board of Trustees of The Memorial Hospital of Carbon County, submit their resignations from said Board.

NOW THEREFORE, BE IT RESOLVED, by The Board of the County Commissioners of the County of Carbon that the present Board of Trustees of The Memorial Hospital of Carbon County, composed of the following named persons: W. W. Daley, A. R. McMicken, Joseph H. Neath, Day P. Espy, and E. P. Murphy, submit their written resignations to The Board of the County Commissioners of the County of Carbon before July 11, 1946, or in the alternative, the Board of Trustees of The Memorial Hospital of Carbon County, or any of the members thereof, appear before The Board of the County Commissioners of the County of Carbon at its office in the Court House Building, Rawlins, Wyoming, at two o'clock in the afternoon of said day to show cause, if any they have, why said Board or any member thereof should not be removed.

BE IT FURTHER RESOLVED, that a copy of this Resolution be, by Special Delivery, registered mail, with return receipt requested, addressed to each and every member of the Board of Trustees of The Memorial Hospital of Carbon County.

The above and foregoing Resolution was, upon Motion of Commissioner John Cheesbrough, seconded by Commissioner Eugene McCarthy, passed and adopted by The Board of the County Commissioners of the County of Carbon this 3rd day of July, 1946, and made a part of the official proceedings of said Board.

There being no further business the meeting was adjourned.
