DIXON-SAVERY ROAD

It was regularly moved by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried that the Board of Commissioners adopt the following resolution:

RESOLUTION TO LOCATE ROAD

WHEREAS, public necessity requires that the following road be established,

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to wit:

Wyo. Project No. S 43 (2)  
Carbon County

NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Dixon-Savery Road commencing at a point which is on the east corporate limits of Dixon which point is N. 89° 11'E., 599.7 feet of a point which is S 89° 28'E. 298.0 feet from the section corner common to sections 4, 5, 8 and 9, T. 12 N., R. 90 W.; thence in an easterly direction a distance of 4.55 miles to the town of Savery,

The proposed location and width of right-of-way required are set forth in detail on map on file with the County Clerk and may be examined at his office.


All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 9th day of Sept. A. D., 1946, or such road will be established without reference to such objections or claims for damages.
