County Surveyor S. S. Sharp met with the Board relative to the New Mullison Park Road, and also presented a map and description of same.

#### NEW MULLISON PARK ROAD

It was regularly moved by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried that the Board of Commissioners adopt the following resolution:

#### RESOLUTION TO LOCATE ROAD

WHEREAS, public necessity requires that the following road be established;

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to-wit:

New Mullison Park Road  
Carbon County

#### NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the New Mullison Park Road commencing at a point

25 feet west of the east line of Lot 5, Section 2, T. 16 N., R. 82 W., located S.  $31^{\circ} 08'$  E. 2505 feet from the northwest corner of said Section 2, T. 16 N., R. 82 W. (said point of beginning being located on the north boundary of the right-of-way of the present Saratoga-Ten Mile Road); thence North  $494'$  feet, to a point on the line between Lots 5 and 4 of said Section 2; thence north  $1493'$  feet; thence N.  $44^{\circ} 58'$  W. 1199 feet; thence N.  $1^{\circ} 51'$  E. 634 feet, to a point on the north line of the  $SE\frac{1}{4} SW\frac{1}{4}$  of Section 35, T. 17 N., R. 82 W., where this survey connects with the original Mullison Park Road. Total length, 3820 feet, or 0.723 mile.

The proposed location and width of right-of-way required are set forth in detail on map on file with the County Clerk and may be examined at this office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 2nd day of October, A. D., 1946, or such road will be established without reference to such objections or claims for damages.

Thereupon the Board adjourned until the following day.

Sept. 4, 1946

The Board resumed its session with all members present.

State Highway Department engineers Wiley and Ingram met with the Board relative to the Dixon-Savery road. Commissioners McCarthy and Gooldy accompanied the engineers to Dixon to view the proposed location and to interview the land owners.
