COMMISSIONERS PROCEEDINGS

REGULAR MEETING

The Board of Commissioners met Oct. 1, 1946 at 10:00 A.M. all present, Eugene McCarthy Chairman.

The minutes of meetings held Sept. 3-4-5 and 9 were read and approved.

APPOINTMENT. The appointment of Mary Cooper as Deputy Clerk of Court was approved by the Board.

County Surveyor S. S. Sharp met with the Board relative to the Connecting Road South from the Saratoga-Centennial Highway and presented a map and description of same.

CONNECTING ROAD SOUTH from SARATOGA-CENTENNIAL HIGHWAY.

It was regularly moved by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried that the Board of Commissioners adopt the following resolution:

RESOLUTION TO LOCATE ROAD.

WHEREAS, public necessity requires that the following road be established;

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to-wit:

CONNECTING ROAD SOUTH from SARATOGA-CENTENNIAL HIGHWAY. CARBON COUNTY.

NOTICE OF LOCATION OF PUBLIC ROAD.

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the Connecting Road South from the Saratoga-Centennial Highway commencing at a point which is located N. $45^{\circ} 25'$ W. 1868 feet from the east quarter-corner of Section 22, T. 16 N., R. 83 W., said point being on the south line of the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 22, and 30 feet distant from the southeast corner of the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 22; thence N. $0^{\circ} 34'$ E. 1028 feet; thence N. $28^{\circ} 44'$ E. 456 feet to a point on the south boundary of the right-of-way of the Saratoga-Centennial State Highway.

Right-of-way 60 feet in width, being 30 feet on each side of a center-line; total length of said road is 1484 feet, or 0.28 mile.

The proposed location and width of right-of-way are set forth in detail on map on file with the County Clerk and may be examined at this office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 7th day of November, A. D. 1946, or such road will be established without reference to such objections or claims for damages.

NOTICE AND RESOLUTION TO ABANDON A PUBLIC ROAD.

TO WHOM IT MAY CONCERN:

The Board of County Commissioners have decided to abandon a certain portion of the old Saratoga-Centennial Road, described as follows:

Beginning at a point on the Saratoga-Encampment State Highway located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 16, T. 16 N., R. 83 W. running thence in a general easterly and northeasterly direction through the S $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 16, SW $\frac{1}{4}$ SW $\frac{1}{4}$ and N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 15, T. 16 N., R. 83 W., to its junction with the new location of the Saratoga-Centennial State Highway.

The location of the road to be abandoned is set forth in detail on a map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages from the proposed abandonment of said road must be filed in writing with the County Clerk of said County before noon on the 7th day of November, A. D. 1946, or such road will be abandoned and closed without reference to such objections or claims.
