COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met October 3, 1946 at 10:00 a. m., all members present, Eugene McCarthy Chairman, for the purpose of issuing the General Election Proclamation for November 5, 1946.

The Board decided that the election boards appointed for the Primary Election held July 16, 1946 be re-appointed for the General Election November 5, 1946 and that the County Clerk be authorized to fill any vacancies that may occur and to accept the recommendations of the Democratic and Republican Central Committees.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried whereby the following Election Proclamation be issued.

PROPOSED CONSTITUTIONAL AMENDMENT NO. 1

Proposal to repeal Section 4, Article III of the Constitution of the State of Wyoming, which reads as follows:

"That section 4 of Article III of the Constitution of the State of Wyoming be proposed for repeal to the electors of the State of Wyoming at the next General Election to be held in said State, for their approval or rejection, said repeal to become valid if ratified by a majority of said electors."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 2

Proposal to amend the Constitution of the State of Wyoming by the addition of a section to be designated as Section 11 of Article XVI of said Constitution, which section reads as follows:

"Article XVI, Section 11. The provisions of Section 6 of Article XVI of this Constitution prohibiting the State from engaging in any work of internal improvement unless authorized by a two-thirds vote of the people, shall not apply to or affect the construction, maintenance or improvement of public airports, aircraft landing strips and related facilities but the Legislature shall have power to provide for the construction, maintenance and improvement of public airports, aircraft landing strips and related facilities, in whole or in part by the State, either directly or by extending aid to its political subdivisions and, notwithstanding said inhibition as to works of internal improvement, whenever grants of land or other property shall have been made to the State, especially dedicated by the grant to particular works of internal improvement, the State may carry on such particular works and shall devote thereto the avails of such grants, and may pledge or appropriate the revenues derived from such works in the aid of their completion and maintenance."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 3

Proposal to amend Section 6 of Article XV of the Constitution of the State of Wyoming to read as follows:


"Article XV, Section 6. No tax shall be levied by or for any incorporated city or town exceeding twelve mills on the dollar in any one year, except for the payment of its public debt and the interest thereon."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 4

Proposal to amend the Constitution of the State of Wyoming by the addition of a section to be designated Section 24 of Article VII of said Constitution, which section reads as follows:

"Section 24. The provisions of Section 18 of Article VII of this Constitution requiring charitable, reformatory and penal institutions established and supported by said State to be under the general supervision of its State Board of Charities and Reforms, shall not be applicable to any home, hospital or other institution established by said State for the care of aged or infirm persons."

NOTICE OF ABANDONMENT OF PUBLIC ROAD.

RESOLUTION

WHEREAS, the Board of Commissioners at their regular meeting held Oct. 1, 1946 adopted a resolution to abandon a portion of the old Saratoga-Centennial Highway which is described on Page 171 of Commissioners Record No 10, and

WHEREAS, the time for hearing of protests and claims for damages from such abandonment expired at noon on November 7, 1946, and

WHEREAS, no protests or claims for damages were filed.

NOW, THEREFORE, it is hereby resolved that this road be abandoned subject to the terms of the agreement submitted to the Commissioners by the Board of Appraisers on February 14, 1945.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried whereby the following resolution was adopted relative to the establishment of the Connecting Road South from the Saratoga-Centennial Highway.

WHEREAS, The Board of Commissioners at their regular meeting held on Oct. 1, 1946 made a resolution to locate a road known as the Connecting Road South from the Saratoga-Centennial Highway, and which is described in detail on Page 171 of Commissioners Record No. 10 and map on file in the office of the County Clerk, and

WHEREAS, the date of hearing of protests and claims for damages was set for noon on Nov. 7, 1946, and

WHEREAS, a claim for damages was received from W. C. Condict, and upon further investigation by the Board of Commissioners, it was found that this proposed road was unnecessary.

NOW, THEREFORE, be it resolved that the Board of Commissioners in their regularly meeting of November 7, 1946 do hereby declare that this proposed road location be abandoned. ^{called} in the name of the County
