COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met March 25, 1946 at 10:00 a. m., all present, Eugene McCarthy Chairman.

The meeting was called for the purpose of considering several matters pertaining to County and State highways.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried whereby the following resolution was adopted:

SAGE CREEK ROAD

R E S O L U T I O N

WHEREAS the Board of County Commissioners of the County of CARBON, is desirous of taking advantage of the provisions of Chapter 152, Session Laws of Wyoming, 1945, by co-operating with the State Highway Commission of Wyoming in the improvement of a County road, the location and extent of which is as follows:

That the road known as the Sage Creek Road leading south from Rawlins and connecting with the Forest Road approximately 50 miles south, be graveled and such changes in location be made as are deemed necessary by the State Highway Department, and that this work proceed as far as the funds now available through the State-County cooperating provisions will allow.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of the Board.

DIXON-SAVERY ROAD

The Board of Commissioners decided that the Board recommend to the State Highway Department that the route known as Dolan Mesa between Dixon and Savery be the location of the proposed road between Dixon and Savery, and that the survey be conducted on this route, this also being the route desired by the residents and ranchers in this community. *Road*

RAWLINS-MEDICINE BOW ROAD

It was regularly moved by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried that the Board of Commissioners adopt the following resolution:

RESOLUTION TO LOCATE ROAD

WHEREAS, public necessity requires that the following road be established, *Road*

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to wit:

NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Rawlins-Medicine Bow commencing at a point in Section 4, T22N., R79W of the 6th P.M. Wyoming which point is S76°13'E. 3199.1 feet of a point which is S0°17'W. 18.5 feet of the W $\frac{1}{4}$ corner of said Section 4; thence in a westerly direction through Sections 4, 5, and 6 T22N, R79W, Section 1, 2, 3, and 4 T22N., R80W to a point on the west line of said Section 4, T22N., R80W, which point is S51°21'W, 349.2 feet of a point which is S49°36'W, 1907.4 feet of a point which is S78°44'W, 3582.8 feet of a point which is S0°02'E, 1004.1 feet from the NE corner of said Section 4 T22N., R80W. *Road*

The proposed location and width of right of way required are set forth in detail on Map on file with the County Clerk and may be examined at this office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 8th day of May, A. D. 1946, or such road will be established without reference to such objections or claims for damages.

Thereupon the Board adjourned until the next regular meeting.
