COMMISSIONERS' PROCEEDINGS

REGULAR MEETING

The Board of Commissioners met April 2, 1946 at 10:00 a. m., all present, Eugene McCarthy, Chairman.

The minutes of meetings held March 5, 6, 11 and 25 were read and approved.

MALT BEVERAGE LICENSE:

There being no protests entered, Malt Beverage License No. 108 was granted to Joe M. Quintana of Walcott, Wyoming for the sum of \$100.00 by the unanimous action of the Board.

RETAIL LIQUOR LICENSE:

There being no protests entered, Retail Liquor License No. 26 was granted to John Leister of Lamont, Wyoming for the sum of \$300.00, by the unanimous action of the Board.

The application of Walbye, Seavey and Walbye for Retail Liquor License was rejected and returned to the Board of Commissioners by the Wyoming Liquor Commission.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and unanimously carried, whereby the following resolution was adopted:

RESOLUTION

WHEREAS, the District Court Budget will be depleted this month by the reason of unexpected court costs,

IT IS HEREBY RESOLVED, in compliance with Chapter 110 of the Session Laws of Wyoming, 1945, Section 11 of the Municipal Budget Act, that the County Treasurer be authorized to transfer from the Cash Reserve Fund the sum of \$10,000.00 to supplement this budget.

The Board of County Commissioners unanimously authorized the Budget Officer to publish notice of intention to transfer \$1,000.00 from the Cash Reserve Fund to the budget of the County Attorney in compliance with Section 11 of the Municipal Budget Act adopted in the Session Laws of Wyoming, 1945.
