COMMISSIONERS' PROCEEDINGS

REGULAR MEETING

The Board of Commissioners met May 7, 1946 at 10:00 a.m., all present, Eugene McCarthy, Chairman.

The minutes of meetings held April 2 and 3, 1946 were read and approved.

MALT BEVERAGE LICENSE:

There being no protests entered, Malt Beverage License No. 109 was granted to A. R. Anderson of Coyote Springs, Walcott, Wyoming for the sum of \$100.00 by the unanimous action of the Board.

The Malt Beverage Permit application of Carl W. Anderson of Leo, Wyoming, was rejected by the Board, a protest having been received from the Bureau of Reclamation in Casper, Wyoming.

The Board approved the transfer of Malt Beverage Permit No. 105 which was issued to J. N. Crane at Kilburn Junction, Walcott, Wyoming to Darel J. Gillilan, who has purchased Mr. Crane's business.

Special Sunday Picnic Licenses for the sale of Malt Beverages were issued to A. R. Anderson of Coyote Springs, Walcott, Wyoming for the following dates: June 2, 1946; July 14, 1946; July 28, 1946; August 11, 1946; August 25, 1946; September 1, 1946 for the sum of \$6.00.

A motion was made by Commissioner Gooldy, seconded by Cheesbrough and carried, whereby the Rawlins Daily Times was designated as the official newspaper for the County of Carbon for the unexpired term of the Carbon County News.

TRANSFER OF FUNDS: The Board authorized the Budget Officer to publish notice of intention to transfer \$1000 to the County Sheriff's budget and \$1000 to the Courthouse & Jail budget from the Cash Reserve fund in compliance with Sec. 11, Chapter 110 of the Municipal Budget Act as adopted in the Session Laws of Wyoming, 1945.

TRANSFER OF FUNDS FROM CASH RESERVE:

On April 2, 1946 the Board of Commissioners authorized the Budget Officer to publish notice of intention to transfer \$1,000.00 from the Cash Reserve Fund to the budget of the County Attorney, in compliance with Sec. 11, Chapter 110 of the Municipal Budget Act, Session Laws 1945.

There being no protests or objections presented, a motion was made by Commissioner Cheesbrough, seconded by Gooldy and carried whereby the following resolution was adopted:

R E S O L U T I O N

WHEREAS, the budget appropriation for the County Attorney's office for 1945-1946 has become depleted by reason of unexpected court costs requiring a Deputy County Attorney;

NOW, THEREFORE, be it resolved that the County Treasurer be and is hereby authorized to transfer the sum of \$1,000.00 from the Cash Reserve Fund to supplement the budget of the County Attorney.

WATER COMMISSIONER:

Cloyd A. Crone was appointed as Water Commissioner for District No. 13, Charles Bundy resigned. This district is comprised of Saylor, Lost and Sage Creeks in the northern portion of Carbon County. This appointment was sent to Ambrose D. Hemingway, Sup't of District No. 1 for endorsement.

A petition signed by water users in the Rock River-McFadden District No. 9 urging the retention of Leslie Buck as Commissioner was received by the Board together with a letter from L. C. Bishop of the State Board of Control. Mr. Bishop advised that no petition has been received for appointment of a new Commissioner. Messrs: Bosler and Sims met with the Board relative to appointment of a new Commissioner. No action was taken as this is a joint agreement between Albany and Carbon Counties and the Board felt that the Board in Albany County should also be consulted before any change is made.

Thereupon the Board adjourned until the following day.

MAY 8, 1946.

The Board resumed its session at 10:00 A. M. all present, Eugene McCarthy chairman.

The monthly reports of County Officers were audited and placed on file.

SCHOOL DIST. TREAS. BOND of A. L. Spurlock, District No. 12 for \$2000 was approved.

FAIR GROUNDS:

Attorney J. J. Hickey, F. W. Nickel and Guy Hall met with the Board to discuss the lot west of the fair buildings which has been used in the past for carnivals etc. and which is leased from the City by the County. The lease expires on Mar. 4, 1951 and has a 20 year option clause. They want to lease this land from the City provided the County will cancel their lease. Definite action was not taken but the Commissioners agreed that these men should go before the City Council with their proposition for further action.

COUNTY FIRE TRUCK:

A delegation representing the Rawlins Fire Department met with the Board to discuss the possibility of purchasing a County Fire truck to be used for fires outside of the limits of Rawlins only. It was explained to the Board that the cost of such equipment would be around \$6000.00. The Commissioners decided to investigate the legality of such an expenditure with advice from the County Attorney.


ADDITIONAL COUNTY LIQUOR LICENSE:
