COMMISSIONERS' PROCEEDINGS
SPECIAL MEETING

A special meeting of the Board of County Commissioners of Carbon County, Wyoming, was held at the Commissioners' office in the Courthouse at Rawlins, Wyoming, on the 26th day of June, 1947, pursuant to due notice and call.

The Chairman called the meeting to order and upon roll call, it was found that the following were present:

The following proceedings, among others, were had and taken, to-wit:
Thereupon Commissioner J. J. (Jack) Sullivan introduced the following resolution:

R E S O L U T I O N

A RESOLUTION PROVIDING FOR THE PUBLICATION
OF NOTICE OF SALE OF CARBON COUNTY, WYOMING,
FAIR GROUNDS BONDS.

WHEREAS, the electors of the County of Carbon, Wyoming, will vote
at a special election, called and held for the purpose of authorizing the
Board of County Commissioners to issue the bonds of the County in the
amount of Thirty-five Thousand Dollars for the purpose of improving and
developing the Fair Grounds of said County; and

WHEREAS, the laws of the State of Wyoming require that such bonds be sold after public advertisement:

THEREFORE, BE IT RESOLVED, that the County Clerk of the County of Carbon, be, and he hereby is, authorized and directed to cause to be published in a newspaper of general circulation in Carbon County, Wyoming, and in a newspaper of general circulation in Cheyenne, Wyoming, and in a newspaper of general circulation in Chicago, Illinois, and in a newspaper of general circulation in New York, New York, for three consecutive weeks, a Notice of Sale of bonds to be in substantially the following form:

NOTICE OF SALE

FAIR GROUNDS BONDS

PUBLIC NOTICE IS HEREBY GIVEN, That the County of Carbon, Wyoming, will receive sealed bids for the purchase of the following described Fair Grounds bonds of the County of Carbon until Noon, the 24th day of July, 1947, at 12:00 o'clock Noon, at the office of the County Clerk of said County, and will at 2:00 o'clock, P. M. of the last day named for receiving bids publicly open sealed bids for the purchase of said bonds described as follows:

\$35,000.00 Fair Grounds Bonds, dated July 1, 1947, numbered 1 to 35, both inclusive, in the denomination of \$1,000.00 each, maturing serially \$3,000.00 on the first day of July in each of the years 1949 to 1959, inclusive, and \$2,000.00 on the first day of July, 1960, bearing interest at the rate of not to exceed three per centum per annum, payable semi-annually on the first day of January and the first day of July in each year.

Bidders are requested to specify the lowest rate of interest at which they will purchase said bonds at par. None of said bonds will be sold at less than par, plus accrued interest, nor will any discount or commission be allowed or paid on the sale of said bonds. All bids shall be sealed and shall be accompanied by a deposit of five per cent of the bid, which shall be in cash or certified check, which deposit will be returned if the bid is not accepted; and if the successful bidder shall fail or neglect to complete the purchase of said bonds within five days following the acceptance of his bid, the amount of his deposit shall be forfeited to the County of Carbon, and in that event the corporate authorities of said County may either accept the bid of the one making the next best bid or reject all bids and readvertise the bonds for sale. The corporate authorities may, in any event, reject all bids and readvertise the bonds for sale. If there be two or more equal bids and such bids are the best bids received, and are not less than par plus accrued interest, the corporate authorities shall determine which bid shall be accepted, and if a bid be accepted, the deposit of all other bidders shall thereupon be returned; if all be rejected, then all deposits will be returned forthwith.
