COMMISSIONERS' PROCEEDINGS
REGULAR MEETING

The Board of Commissioners met at 10:00 a.m. October 7, 1947, Cheesbrough and McCarthy present, Sullivan absent. The minutes of meetings held September 2 and 3, 1947 were read and approved.

SAGE CREEK ROAD SC 2433 (47)

A motion was duly made, seconded and carried whereby the Board of Commissioners hereby agree to guarantee the right of way as proposed by the State Highway Department from the top of Middlewood Hill to Chalk Hill, a distance of approximately 5 miles, and to save the State harmless if any protest should be received in the matter of this new road location.

LIQUOR LICENSE - Martin & Tully, Three Forks

There being no protests entered, Liquor License No. 30 was issued to D. E. M. Martin and R. S. Tully of Three Forks Service Station, Rawlins, Wyoming located 45 miles north of Rawlins, for the sum of \$300.00.


