COMMISSIONERS' PROCEEDINGS
REGULAR MEETING

The Board of Commissioners met at 10:00 a.m., all members present, John Cheesbrough, Chairman.

The minutes of meetings held November 4 and 5, 1947 were read and approved.

The Board then proceeded to act as a canvassing board as required by Section 67-807 of the Wyoming Compiled Statutes for 1945, to canvass the returns of the Special School Bond Election held within School District No. 3 in the County of Carbon and State of Wyoming, on November 4, 1947, at which was submitted to the voters of said District the following question:

"Shall the Board of Trustees of School District No. 3, in the County of Carbon, State of Wyoming, be authorized to issue the coupon bonds of the district in an amount not to exceed \$600,000, said bonds to be dated January 1, 1948, to bear interest at a rate not to exceed 3% per annum payable semiannually and to mature serially \$40,000 on July 1st in each of the years 1949 to 1963, both inclusive, subject to redemption on July 1, 1959, and on any interest payment date thereafter, for the purpose of the erection of school buildings therein and the equipment of the same?",

and upon the conclusion thereof, the Board found that the proposal so submitted carried in the affirmative by the following vote:
