The Board resumed its session, all members present.

MONTHLY REPORTS of County Officers were audited and approved and placed on file.

POLL TAX - A motion was made by Commissioner Sullivan, seconded by McCarthy and carried whereby the County Assessor was authorized to proceed with the collection of Poll Tax for 1947.

BONDS - The bond of Mary Jean Goffar, Deputy County Clerk in the amount of \$1500 was approved by the Board.

FOREST RESERVE FEES DISTRIBUTION:

MEDICINE BOW-CASPER HIGHWAY SURVEY:

RAFD

A delegation from the Medicine Bow Lions Club met with the board to discuss the survey of the Medicine Bow-Casper Highway cut-off. A resolution was presented to the Board urging the Highway Department to proceed with this survey. No action was taken on the resolution as the Board decided to write to Superintendent Bromley of the Highway Department requesting information as to when such a survey could be made.

Nels Dahlquist, County Agent, and Richard Seith, Game Warden, met with the Commissioners relative to funds to be used in the eradication of magpies in various sections of the County. The Commissioners advised that there is no fund in the budget for such a project at this time. No further action was taken.

THE CARBON COUNTY FAIR BOARD met with the Commissioners relative to holding a special election for a bond issue to finance the erection of a building at the County Fair grounds for use as a sales ring and recreation center.

There being no funds in the budget for election purposes until the next budget, the County Attorney advised the Board that it is his opinion that no funds could be drawn from the Reserve Fund to hold such an election at this time. He further advised that he would write to the Attorney General for his opinion. Thereupon the Board adjourned until the following day.

March 6, 1947

The Board resumed its session, all members present.

The County Clerk was instructed to write to the Wyoming Liquor Commission relative to issuing a liquor license for Ten Mile, 18 miles southeast of Saratoga, Wyoming.

Several matters of routine County business were disposed of, after which the Board adjourned subject to the call of the Chairman.
