ABANDONMENT - MILO ROAD

On September 2, 9, 16, and 23, 1949 the Board of Commissioners published a Notice of Abandonment of the Milo Road with final hearing to be on or before noon on October 5, 1949. There being no protests or claims for damages, a motion was made by Commissioner Cheesbrough, seconded by McCarthy and unanimously carried whereby the following resolution was adopted:

R E S O L U T I O N

WHEREAS, the maintenance of the County Road known as the Milo Road, described in Book 7, of the Commissioners' Record on page 132, and appearing in the Road Book on page 27, is no longer essential, and this road is no longer in use by the general public; and

WHEREAS, Notice of Abandonment of said road has been duly advertised and protests have been heard and considered;

NOW THEREFORE, be it resolved, that the present Milo Road in Sections 18 and 17, Township 19 North of Range 80 West of the 6th P.M., be, and is hereby declared abandoned.

Wm. N. Brimmer and Douglas Dinsmore, representing the Junior Chamber of Commerce requested permission from the Board of Commissioners to continue the use of the County Fair Building for boxing matches for the ensuing year to be held at times not in conflict with the County Fair or agricultural activities. The Board unanimously approved this request.

There being no further business, the Board adjourned until October 8, 1949.

ADDITION TO MINUTES of Sept. 7, 1949:

The County Treasurer was authorized to transfer \$10,000.00 from the R & B Sinking Fund to the General Fund; \$1,700.00 was transferred from the County General Reserve Fund to the County Fair Fund to defray expenses of the County Fair for the reason that 1949 taxes will not be collected until October and November in sufficient amounts to pay from the County Fair Fund. It is understood that as soon as taxes are collected by the Treasurer's Office, the same amount will be credited to the County General Reserve Fund.

The Treasurer was also authorized to transfer amounts necessary to retire interest coupons on Carbon County Memorial Hospital Bonds which became payable September 1, 1949. This transfer to be made from the sale of bonds which have not as yet been used for the construction of the new building. As soon as 1949 taxes are collected the Treasurer will replace this expenditure in the Memorial Hospital Bond Fund.
