TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Rawlins-Medicine Bow Road, Wyoming Project FI 221 (4), commencing at a point which is N. 0° 06' E., a distance of 476.1 feet from the corner of sections 5, 6, 7, and 8, T. 21 N., R. 82 W.; thence running in a southwesterly direction for a distance of 4.3 miles through sections 6 and 7, T. 21 N., R. 82 W., and through sections 12, 11, 14 and 15, T. 21 N., R. 83 W., to a point on the west boundary of said section 15, from which point the northwest corner thereof bears northerly a distance of 1671.4 feet.

R E S O L U T I O N

A RESOLUTION PROVIDING FOR THE PUBLICATION OF NOTICE OF SALE OF
CARBON COUNTY, WYOMING, MEMORIAL HOSPITAL BONDS.

WHEREAS, the electors of the County of Carbon, Wyoming, at a special election, called and held on the 2nd day of November, 1948, authorized the Board of County Commissioners to issue the bonds

of the County in the amount of \$450,000.00 for the purpose of enlarging, improving and equipping the present Carbon County Memorial Hospital; and

WHEREAS, the laws of the State of Wyoming require that such bonds be sold after public advertisement:

THEREFORE, BE IT RESOLVED, that the County Clerk of the County of Carbon, be, and he hereby is, authorized and directed to cause to be published in a newspaper of general circulation in Carbon County, Wyoming, and in a newspaper of general circulation in Cheyenne, Wyoming, and in a newspaper of general circulation in Denver, Colorado, and in a newspaper of general circulation in Chicago, Illinois, and in a newspaper of general circulation in New York, New York, for three consecutive weeks, the Notice of Sale of bonds to be in substantially the following form:

PUBLIC NOTICE IS HEREBY GIVEN That the County of Carbon, Wyoming, will receive sealed bids for the purchase of the following described Memorial Hospital Bonds of the County of Carbon until noon the 15 day of February, 1949, at 12:00 o'clock noon, at the office of the County Clerk of said County, and will at 2:00 o'clock, P. M., of the last day named for receiving bids publicly open sealed bids for the purchase of said bonds described as follows:

\$450,000.00 Memorial Hospital Bonds, dated March 1, 1949, numbered 1 to 450, both

inclusive, in the denomination of \$1,000.00 each, maturing serially \$25,000.00 on the first day of March in each of the years 1950 to 1967, both inclusive, bearing interest at the rate of not to exceed four per centum per annum, payable semiannually on the first days of March and September in each year, bonds maturing on the first day of March, 1960, and thereafter, being redeemable at the option of the County on the first day of March, 1959, and on any interest payment date thereafter.

Bidders are requested to specify the lowest rate of interest at which they will purchase said bonds at par. None of said bonds will be sold at less than par, plus accrued interest, nor will any discount or commission be allowed or paid on the sale of said bonds. All bids shall be sealed and shall be accompanied by a deposit of five per cent of the bid, which shall be in cash or certified check, which deposit will be returned if the bid is not accepted; and if the successful bidder shall fail or neglect to complete the purchase of said bonds within five days following the acceptance of his bid, the amount of his deposit shall be forfeited to the County of Carbon, and in that event the corporate authorities of said County may either accept the bid of the one making the next best bid or reject all bids and readvertise the bonds for sale. The corporate authorities may, in any event, reject all bids and re-advertise the bonds for sale. If there be two or more equal bids and such bids are the best bids received, and are not less than par plus accrued interest, the corporate authorities shall determine which bid shall be accepted, and if a bid be accepted, the deposit of all other bidders shall thereupon be returned; if all be rejected, then all deposits will be returned forthwith.

The legality of the bonds will be approved by Messrs. Pershing, Bosworth, Dick & Dawson, Attorneys at Law, Denver, Colorado, whose opinion, together with the printed bonds, will be furnished the purchaser without charge.
