SPECIAL MEETING

A special meeting was called; Commissioners Sullivan and Cheesbrough present; McCarthy, absent, for the purpose of considering repairs on the Hanna-L-Plane Mine Road under State-County cooperative agreement.

A motion was made by Commissioner Cheesbrough, seconded by Sullivan and carried whereby the following resolution was adopted:

HANNA-L-PLANE ROAD

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the Provisions of Section 1, Chapter 12, Session Laws of Wyoming, 1947, by co-operating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Resurfacing of the Hanna-L-Plane Mine Road, Carbon County, Wyoming

NOW, THEREFORE, be it resolved by said Board:

That the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the Chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of the Board.
