RAWLINS-SAGE CREEK ROAD. The Board of Commissioners requested a change in the agreement on the above road dated December 7, 1949 covering co-operative improvement of a section of the Rawlins-Sage Creek Road extending from the Medicine Bow National Forest boundary Northerly, to be voided; and the following described road section is substituted in lieu thereof:

A section of the Rawlins-Sage Creek Road approximately 6 miles in length extending from the Miller Hill Road junction near the North boundary of Township 18 North, Range 88 West, Northerly to the South end of the proposed Federal Aid Project S-75(1).

The new agreement was signed by the Board of Commissioners and sent to the Wyoming Highway Department for their approval.
