ABANDONMENT OF ELK MOUNTAIN TO BOW RANGER STATION ROAD.

A petition was received from several land owners along this road requesting abandonment of a portion of the County road as follows:

The Board unanimously decided to abandon this piece of County road and ordered the following Notice of Abandonment of Public Roads be published; and land owners be notified.

The Board of County Commissioners of Carbon County, Wyoming, have decided to abandon a portion of the County road from Elk Mountain to Bow Ranger Station, commencing at the west quarter-corner of Section 28, T. 20 N., R. 80 W., running thence south along section lines to the SW corner of Section 16, T. 19 N., R. 80 W.

The reason for the proposed abandonment is that the above portion of said road is no longer in use by the general public, and has been replaced by another road in this vicinity.

The location of the road to be abandoned is set forth in detail in the office of the County Clerk, in the Road Book on page 28.

All objections and claims for damages must be filed in writing with the County Clerk of said County before noon on July 6, A.D., 1950, or such road will be abandoned without reference to such objections or claims for damages.

STATE PROJECT SC 2710 - RAWLINS-SAGE CREEK ROAD

The Wyoming Highway Department approved the change in Agreement dated Dec. 7, 1949, covering co-operative improvement of a section of the Rawlins-Sage Creek Road extending from the Medicine Bow National Forest boundary Northerly is hereby voided, and the following described road section is substituted in lieu thereof.

A section of the Rawlins-Sage Creek Road approximately 6 miles in length extending from the Miller Hill Road junction near the North boundary of Township 18 North, Range 88 West, Northerly to the South end of the proposed Federal Aid Project S-75(1).

CERTIFICATE OF PURCHASE NO. 3566 was sold to Robert C. Wiant of Saratoga. Part of Lot 16, all of lot 17, Block 29, S. R. E. & I Co's First addition to Saratoga, for the sum of \$10.06.
