ABANDONMENT OF ELK MOUNTAIN TO BOW RANGER STATION COUNTY ROAD

On June 8, 15, 22 and 29, the Board of Commissioners published a notice of abandonment of the above-mentioned road with final hearing to be before noon on July 6, 1950. Letters of protest were received from John G. Boberg, Osea Nelaon, Inc. and George J. Ojala.

An agreement for right of way was entered into between Adrian Menke and John G. Boberg, and Mr. Boberg withdrew his protest.

A motion was then made by Commissioner Cheesbrough, seconded by McCarthy and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, the maintenance of the county road known as the Elk Mountain-Bow Ranger Station road, described in detail in the office of the County Clerk in the Road Book on page 28 and Commissioners Record No. 10 on page 361, is no longer essential and this road is no longer in use by the general public; and

WHEREAS, notice of abandonment of said road has been duly advertised and protests have been heard and considered;

NOW THEREFORE, be it resolved that the present Elk Mountain-Bow Ranger Station road in Sec. 28, T. 20 N., R. 80 W. and Sec. 16, T. 19 N., R. 80 W. of the 6th P.M. be, and is hereby declared abandoned.

RAWLINS-SAGE CREEK ROAD

STATE PROJECT S- 75 (1)

Motion was made by Commissioner Cheesbrough, seconded by McCarthy and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, deems that the public interest requires that a road be established, to be known as the Rawlins-Sage Creek road, State Project S- 75 (1), described as follows:

Beginning at the intersection of Davis and Bennett Streets of the City of Rawlins in Sec. 20, T. 21 N., R. 88 W. and running in a southerly direction through Sections 20, 19, 30 and 31, T. 21 N., R. 88 W. and Sections 1, 12, 11, 14, 23, 26, 35 and 36, T. 20 N., R. 88 W. and Sections 1 and 2, T. 19 N., R. 88 W. to a point on the north and south center line of said Section 2 from which the east quarter corner thereof bears easterly a distance of 687 feet, more or less. The location being shown in detail on maps on file with the County Clerk, and

WHEREAS, all rights of way through private, public and railroad property have been secured through direct negotiation,

NOW THEREFORE, be it resolved, that the said road as described above and shown in detail on maps on file be declared established and a plat of same be ordered placed in the County Road Plat Book and a copy of this resolution be sent to the Wyoming State Highway Department.

Thereupon the Board adjourned until the following day at which time the election districts, election precincts and changes in precincts will be made together with the selection of judges and clerks for the primary and general elections in compliance with Section 36-1101, W.R.S. of 1931.
