TRANSFER OF FUNDS FROM CASH RESERVE. In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as emended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$1500.00 from the Cash Reserve Fund to the Election Budget was published on Nov. 23, 1950. There being no protests a motion was made and unanimously carried whereby the County Treasurer and Budget Officer were authorized to transfer \$1500.00 to the Election Budget, on account of unanticipated election expense.

Thereupon the Board adjourned until the following day.


MONTHLY REPORTS of County Officers were audited and placed on file.

Total Length, 9.224 Miles (Rural)
