STATE-COUNTY ROAD CONSTRUCTION PROGRAM AGREEMENT: A motion was made by Commissioner Cheesbrough, seconded by Salisbury and unanimously carried whereby the following resolution was adopted.

RESOLUTION

Whereas, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 25, Session Laws of Wyoming, 1949, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

The Rawlins-Sage Creek Road extending from the south end of Federal Aid Secondary Construction in Section 2, Twn. 19 N., R 88 W., Southerly, to the Boundary line of the Medicine Bow National Forest in Twn. 14 N., R 88 W.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of the Board.

There being no further business, the Board adjourned its session.
