COMMISSIONERS' PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met at 11:00 A.M., Commissioners McCarthy and Cheesbrough, present, Salisbury, absent.

A Motion was made by Commissioner Cheesbrough, seconded by McCarthy and carried whereby the following resolution was adopted:

R E S O L U T I O N

WHEREAS; The Board of County Commissioners of Carbon County, Wyoming, deems the Public Interest requires that a road be established to be known as the Medicine Bow-North road, Project S- 50 (7), beginning at a point on Highway U.S. 30, which point is S. 0° 21' W. a distance of 1693.1 feet from a point on the north boundary of section 8, T. 22 N., R. 78 W. from which the northwest corner of said section 8 bears N. 89° 37' W. a distance of 1291.1 feet; thence running in a northerly direction through sections 8 and 5, T. 22 N., R. 78 W.; sections 32, 33, 28, 21, 22, 16, 9 and 4, T. 23 N., R. 78 W., and sections 33, 28 and 21, T. 24 N., R. 78 W. to a point which is N. 5° 41' W. a distance of 259.9 feet from a point which is N. 9° 49' E. a distance of 2569.9 feet from a point on the south boundary of section 21, T. 24 N., R. 78 W. from which the southwest corner of said section 21 bears S. 89° 50' W. a distance of 1052.3 feet, the proposed location and width of right of way being shown in detail on Map on file with the County Clerk of said County, Now, Therefore,

BE IT RESOLVED; That the Board declare their intention to establish said road by publication of a Notice of Location and by mailing a copy of said Notice, by registered mail, to all persons owning lands, or claiming any interest in lands, over or across which the said road is to be located, and said notice shall state that all objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon of the 2nd day of July, 1952, or such road will be established without reference to such objections or claims for damages.

N O T I C E O F L O C A T I O N O F P U B L I C R O A D

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as the Medicine Bow-North road, Project S-50 (7), beginning at a point on Highway U.S. 30, which point is S. 0° 21' W. a distance of 1693.1 feet from a point on the north boundary of section 8, T. 22 N., R. 78 W. from which the northwest corner of said section 8 bears N. 89° 37' W. a distance of 1291.1 feet;

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon of the 2nd day of July, 1952, or such road will be established without reference to such objections or claims for damages.
