PASS CREEK ROAD: The Board of Commissioners received a copy of FINDING AND ORDER In the Case of ROCKY MOUNTAIN SHEEP CO., a corporation, Appellant -vs- BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING, Respondent, as the same appears on file and of record in the office of the Clerk of Court, whereby damages in the amount of \$2630.20 were allowed by the Court. DISASTER UNIT PROPOSAL A committee of the following men, William McCauley, D. C. Rudy, Richard Seith, and Louis Gröb, met with the Board to discuss plans for setting up a County disaster unit for emergencies that arise from time to time in the cases of drownings, lost persons and fires. No definite action was taken, but the committee agreed to submit costs of equipment that would be necessary for such County disaster unit. This matter would also require a budget appropriation which would be studied by the Board.
