SEMINOE DAM-NORTH ROAD to Junction with the Alcova-Hanna Road near Leo, Wyoming. The Board received a letter from the Bureau of Reclamation in Casper requesting the transfer of all rights that the County has in this road. A motion was made by Robertson, seconded by Cheesbrough and carried whereby the following Resolution was adopted.

R E S O L U T I O N

WHEREAS, the Bureau of Reclamation of the Department of Interior is desirous of having the road repaired and improved from the Seminoe Camp located at the Seminoe Dam to the point of Junction with the Alcova-Hanna Road near Leo, Wyoming, and

WHEREAS, the County Commissioners of Carbon County, Wyoming can find no evidence that this said road is a County Road, and

Whereas, the County Commissioners of Carbon County, Wyoming are not desirous at this time of making this road a County Road because of lack of sufficient funds with which to properly maintain and improve said road,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Carbon and State of Wyoming that the said County of Carbon claims no interest in and to said road.
