TAX REBATE order No. 1607 was granted to Diane J. Forney, in amount of \$2.00, account Poll Tax, underage.

CERTIFICATE OF PURCHASE NO. 3630 was sold to Joe R. Love, Rawlins, Wyo., on lot 7, block 1, Yoakum Addition to Baggs for \$ 7.96

FOREST RESERVE FEES in compliance of Section 18-403 WCS 1945 in the amount of \$20757.36 were distributed as follows: 95% to General Fund Road & Bridge Department, \$19,719.49; \$1037.87 to School Districts.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as amended in the Session Laws of 1947, a Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was published on Nov. 27, 1954, as follows:

RESOLUTION

WHEREAS, the above budgets have become depleted due to unanticipated costs.

IT IS HEREBY RESOLVED That the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds.

LITTLE SNAKE RIVER BRIDGE - BAGGS - SLATER ROAD, PROJECT NO. S43 - CARBON COUNTY.

The following agreement presented to the Board by the Wyoming Highway Commission was unanimously approved by the Board and signed to-wit:

The Board of County Commissioners of Carbon County, Wyoming approve the re-construction of the approaches and bridge over the Little Snake River at Dixon. (Approximately 0.5 Miles) to be constructed on a portion of the Baggs-Slater road.

This section of road is approximately 0.5 miles in length and further identified as Wyoming Federal Aid Secondary Project No. S-43.

The County Commissioners concur with the Wyoming Highway Commission in the selection of this project for programming with Federal Aid Secondary funds made available under the Federal Aid Highway Act.
