January 5, 1954. A motion was made by Commissioner Robertson, seconded by Salisbury and carried whereby the following resolution was adopted.

RESOLUTION

WHEREAS, the UNION PACIFIC RAILROAD COMPANY has tendered to the COUNTY OF CARBON, STATE OF WYOMING, an agreement extending to February 28, 1959, the term of contract dated August 9, 1934, granting to the County certain rights for highway purposes in portions of the Railroad Company's right of way in Carbon County, Wyoming; said agreement being identified as Union Pacific Railroad Company's C. D. No. 9221-G; and

WHEREAS, the Board of County Commissioners of the County of Carbon has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon will be subserved by the acceptance of said agreement:

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

That the terms of the agreement submitted by the Union Pacific Railroad Company as aforesaid be, and the same are hereby, accepted in behalf of Carbon County:

That the Chairman of the Board of County Commissioners of said County is hereby authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk is hereby authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.

Thereupon the Board adjourned to meet as a District School Boundary Board.

Jan. 6, 1954 The Board resumed its session, Cheesbrough and Robertson present, Salisbury absent.
