COMMISSIONERS PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met at 1:00 P. M. Cheesbrough and Robertson present, Salisbury absent.

WHD

The Board met with Engineer Gattis for the purpose of entering into road program agreements as follows:

SPRING CREEK ROAD — COW CREEK ROAD AND CRUSHING AND STOCKPILING OF SURFACE MATERIAL.

A motion was made by Robertson, seconded by Cheesbrough and carried whereby the following resolution was adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Approximately 10 miles of the Spring Creek Road commencing at the junction with the Saratoga-Encampment road and running in a south-westerly direction to the south line of Township 16 North, Range 84 West.

And approximately 3 miles of the Cow Creek Road commencing at the junction with the Saratoga-Encampment Road and running in a south-westerly direction to the Trowbridge Ranch.

Work consisting of:

Crushing and stockpiling 20,000 tons of 3/4" surfacing material for the Spring Creek road - Section I of this agreement, material to be placed on an existing graded roadbed by County forces, providing a 4" gravel section.

Crushing and stockpiling 9,000 tons of 3/4" surfacing material for the Cow Creek road - Section II of this agreement, material to be placed on an existing graded roadbed by County forces & providing a 6" gravel section.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.

HANNA - LEO ROAD: A motion was made by Robertson, seconded by Cheesbrough and carried whereby the following resolution was adopted:

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

Approximately 4.5 miles of Hanna-Leo Road--commencing at south end of work done under SC-CFM Project 3108 - Sec. II, to the north end of oiled road at L-Plane.

Work to consist of :

Placing an additional 4" base course surfacing section consisting of pitrun sand from the Young-Watkins pit located in Sec. 22, T. 24 N., R. 81 W.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
