BROWN'S HILL ROAD: On March 2nd, 1955 the Board of Commissioners decided to publish a Notice of Location of Public Road, known as, re-location of a section of the Brown's Hill Road in Carbon County, Wyo. The date of hearing was set for April 6, 1955, at which time the Board met with the land owners involved to hear objections and receive claims for damages. Claims for damages were presented to the Board by Joseph Wenger, J. H. Bicktold, Claude E. Shockley and Rambler Sheep Company. After reviewing the claims for damages and hearing the arguments of the land owners it was decided by unanimous action of the board to table this matter in view of the excessive costs of a right-of-way.

BOND the Bond of Mrs. Halsey Kortes, Treasurer of School District No. 2, was approved in the amount of \$3500.00.

CARBON COUNTY LIBRARY BOARD: Mrs. Dave L. Rusk was re-appointed as a member of the Carbon County Library Board for a three year term, commencing July 2, 1955.

SINCLAIR - SEMINOE DAM (SC-CFM 3419)

A motion was made by Cheesbrough and carried whereby the Resolution that was adopted on May 5, 1954, recorded in Commissioners Record No. 10 Page 540 be amended as follows:

Commencing at the north end of Sinclair-Seminole Dam Project, Section 1, (SC-CFM 3418), thence running in a northeasterly direction approximately 3½ miles.

Work to consist of: Remove existing bridges and replace with culverts and base course surfacing.
