January 5, 1955, The Board resumed its session Robertson and Cheesbrough present, Salisbury absent.

A motion was made by Cheesbrough, seconded by Robertson and carried whereby the following resolution was

adopted: Medicine Bow North Road R E S O L U T I O N Wyo. Project S - 50 (10)

WHEREAS, the Wyoming Highway Department has requested the Board of County Commissioners of Carbon County to secure the right of way for a portion of the Medicine Bow-North road, Wyoming Project S - 50 (10), described as follows:

Commencing at a point on the east boundary of Section 17, T. 25 N., R. 78 W., which point is northerly a distance of 203.0 feet from the east quarter corner thereof;  
thence running in a northwesterly direction for a distance of approximately 28 miles through Sections 17, 8, 7, and 6 in T. 25 N., R. 78 W., Section 1 in T. 25 N., R. 79 W., Sections 36, 35, 26, 27, 22, 21, 20, 19 and 18 in T. 26 N., R. 79 W., Sections 13, 14, 11, 10, 9, and 4 in T. 26 N., R. 80 W. Sections 33, 32, 28, 29, 20, 21, 16, 9, 10 and 3 in T. 27 N., R. 80 W. & Secs 34, 27, 22, 15, 10, and 3 in T. 28 N., R. 80 W. of the 6th P.m. Wyo., to a point of ending at the county line on the north boundary of Section 3, T. 28 N., R. 80 W. from which the northwest corner of said Section 3 bears S. 88° 28' W. a distance of 1245.8 feet, and

WHEREAS, The said Board deem the public interest requires that said road be established,

NOW, THEREFORE BE IT RESOLVED; That the Board of County Commissioners of Carbon County, Wyoming, do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road, by following out the provisions of Article 3, Chapter 48, Wyoming Compiled Statutes, 1945 as amended, not inconsistent therewith.

NOTICE OF LOCATION OF PUBLIC ROAD, TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the Medicine Bow North road, Wyoming Project S-50 (10),

Commencing at a point as described in the above resolution.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 8th day of February, A. D. 1955, or such road will be established without reference to such objections or claims for damages.
