COMMISSIONERS MEETING  
SPECIAL MEETINGMEDICINE BOW-NORTH ROAD  
PROJECT NO. S - 50 (10)

The Board of Commissioners met at 10:00 a.m., all members present, E. A. Robertson Sr., Chairman. The Board met in special session, together with WHD Engineer, C. E. Gaffis, Jack Sullivan of the Sullivan Company and Joe M. Burke of the Shamrock Ranch Co. formerly known as Cottonwood Sheep Company to hear claims for damages and protests on the Medicine Bow-North Road, Project S-50 (10) in compliance with the notices advertised in the Rawlins Daily Times on January 8-15 and 22, 1955.

Tom C. Kirk requested that right of way should not exceed 130 feet. Mr. John Adkins of the Wyoming Highway Department through Engineer Clarence Busby contacted Mr. Kirk and it was agreed that he would grant a right of way easement as per map, if woven wire fence was constructed. This was approved by Engineer J. A. Adkins.

Mr. Joe Burke met with the Commissioners and agreed upon the proposed right of way through his property if the following were granted. Construction of woven wire fence, right and left of center line between stations 1118+47 to station 1167+15.7. This section passes thru fenced pasture. Fence the drainage structure at Station 1148+47.5 for use as a stock pass. Three cattle guards be constructed at the following stations, 1125+74.1; station 1169+60 and station 1906+02.7, this last station to serve in new drift fence to be built by owner. Present road to be left intact along with drainage structures for use of the owner. Approach roads to be constructed at all existing trails.

Mr. Jack Sullivan of the Sullivan Company met with the Commissioners and agreed upon the proposed right of way thru his property if the following were granted. Three cattle guards at drift fences located at the following stations. 1399+60; 1526+20; and 1621+20,, and he requested that present road be left intact along with drainage structures for the use of owner and approach roads to be built at all existing trails.


The above requests were approved by the Board of County Commissioners subject to the approval of the Wyoming Highway Department.
