Medicine Bow-North Road

R E S O L U T I O N

Wyoming Project S 50 (10)

WHEREAS, the Wyoming Highway Department has requested the Board of County Commissioners of Carbon County to secure the right of way for a portion of the Medicine Bow-North Road, Wyoming Project No. S 50 (10), described in the Commissioners' Record No. 10, Page 580 and in the Notice of Location of Public Road on record in the Office of County Clerk, which was published on January 8-15 and 22, 1955, and

WHEREAS, all land owners affected by said proposed road have been notified by registered mail, and

WHEREAS, the date of filing objections or claims for damages expired at noon on the 8th day of February, A. D. 1955, and

WHEREAS, no objections or claims for damages were filed, and the necessary easements have been obtained.

NOW THEREFORE, be it resolved, that the road as described in Commissioners' Record No. 10, Page 580 and shown in detail on map on file in the office of the County Clerk of said County, be and is hereby declared established.
