Bromley, Wyoming Highway Superintendent, to discuss improvements to the County portion of this road. A motion was made by Cheesbrough, seconded by Jackson and carried whereby the County will acquire extension of right of way of County road north of Sinclair to the Bureau of Reclamation road south of Seminoe Dam and to petition the Wyoming Highway Department to make a survey with Farm to Market road funds.
